Resolved unanimously – The Committee objected to the planning application on the basis of precedent it could set in a Conservation Area and its intrusive view over the village and into other residents gardens. The Committee though did understand Mr Lovell's personal position and state of health. Therefore, if as outlined in the application, Wiltshire Council considered a "sunlight" clause we would wish to see that restricted to the lifetime of Mr Lovell as the platform is solely for his personal enjoyment.
