7/4. Delegated Responses

a) PL/2025/04439 Lower Upham Farm, Lower Upham – The provision of 156 solar panels situated on the southern roof slopes of 2no rural buildings. DELEGATED DECISION: No comment, no objection.

7/5. Planning applications for consideration

a) PL/2025/05224 62 Whitley Road – Fell 2 x Beech trees. (TPO)

The Committee **RESOLVED** that it understands the possible case for the felling of the tree nearest the house but considers there is potential to pollard the other tree. The Committee defers to the arboriculture officer on a decision about what action should be taken in relation to both trees.

b) PL/2025/05503 & PL/2025/05577 (LBC) Bay House, 5 South Street. – Repair and extension of existing house following demolition of the rear C20 single storey kitchen extension. Replacement of flat roof to the existing two storey extension with two gable roofs. Replacement of the existing single glazed windows with new slimline double glazed windows to match the existing. Limewash paint to existing two storey extension and proposed extension. Internal modifications including restoring the existing fireplaces and modification of the existing partitions.
